I, Kala Agarwal, Practicing Company Secretary, have been appointed as the Scrutinizer by the Board of Directors of **G M BREWERIES LIMITED** ("the Company") to review the remote e-voting and e-voting done during the AGM and votes cast therein based on the data downloaded from the NSDL e-voting system, on the below mentioned resolutions at the 37th Annual General Meetingof the Equity Shareholders of **G M BREWERIES LIMITED**, held on Thursday, 6th August, 2020 at11.30 a.m. through video conferencing ('VC') / other audio visual means ('OAVM'), submit my report as under:

The notice dated 23rd June, 2020, as confirmed by the Company was sent to the Shareholders in respect of the below mentioned resolutions passed at the AGM of the Company through electronic mode to those Members whose email addresses are registered with the Company/ Depositories, in compliance with the MCA Circular dated May 5, 2020 read with circulars dated April 8, 2020 and April 13, 2020 (collectively referred to as "MCA Circulars") and SEBI Circular dated May 12, 2020.

The Company have extended facility of Remote e-voting to the members of the Company through NSDL from Monday, 03rd August, 2020 at 09.00 a.m to Wednesday,5th August, 2020 till 5.00 p.m. IST. and the NSDL e-voting platform was blocked thereafter.

The Company had also provided e-voting facility to the shareholders present at the AGMthrough VC / OAVM and who had not cast their vote earlier.

The book closure started from 31st July, 2020 and ended on 6th August, 2020. The shareholders of the Company holding shares as on 31st July, 2020 were entitled to vote on the resolutions as contained in the Notice of the AGM.

After the closure of e-voting at the AGM, the report on e-voting done at the AGM and thevotes cast under remote e-voting facility prior to the AGM were unblocked and downloaded from the e-voting website of NSDL (https://www.evoting.nsdl.com) in the presence of two witnesses, who are not in the employment of the Company.
